

## PERSONAL GUARANTY

1. The undersigned Guarantors, jointly and severally, unconditionally guarantee payment of all Indebtedness of Debtor to Northwest Pump & Equipment Co. (“NWP”). “Indebtedness” includes all liabilities to NWP of every kind whether due or to become due and including debt to be incurred. This Guaranty is a continuing guaranty until all Indebtedness is satisfied. The undersigned Guarantors represent and warrant to NWP that the following information is true and accurate. Guarantors authorize NWP, without affecting Guarantor’s liability, to change the terms of the Indebtedness without affecting this Guaranty. Guarantor waives presentment, demand upon Debtor, protest, notice of protest, notice of non-payment and notice of any kind with respect to the Indebtedness. Guarantors waive the benefit of any statute of limitations applicable to this Guarantee.

3. Guarantors shall be liable to NWP for all costs and expenses incurred by NWP as to any default by Debtor, including, without limitation, attorney fees. If a lawsuit or arbitration is filed as to this Guaranty, NWP shall be reimbursed by Guarantor for all costs and expenses incurred in the lawsuit or arbitration, including, without limitation, reasonable attorney fees at arbitration, at trial and on appeal. Guarantors consent to the jurisdiction of the state and federal courts of Oregon. The venue for any lawsuit or arbitration shall be in Oregon or as NWP requires.

4. The undersigned personal guarantor, recognizing that his or her individual credit history may be a necessary factor in the evaluation of this personal guaranty, hereby consents to and authorizes the use of a consumer credit report on the undersigned, by the above named business credit grantor, from time to time as may be needed, in the credit evaluation process.
